




On December 13, 2024, the undersigned Circuit Judges of the Twenty-Fourth Judicial Circuit gathered for a regular meeting of the Judges of said Circuit, pursuant to Rule 2-4 of the Rules of Practice for the Circuit Court of Illinois in the Twenty-Fourth Judicial Circuit, at the Monroe County Courthouse in Waterloo, Illinois. All of the undersigned Judges met in person, with the exception of the Hon. James W. Campanella appearing by telephone. Said meeting date was delayed one week from the prescribed date set forth in Rule 2-4, by consensus of the Circuit Judges during a regular Judges' meeting held on September 6, 2024.


Pursuant to Rule 2-1 of the Rules of Practice for the Circuit Court of Illinois in the Twenty-Fourth Judicial Circuit, the attached sample ballot was provided to all said Circuit Judges to elect a Chief Judge for said Circuit. The Trial Court Administrator, Jeff Twardowski, was present to canvass the votes and announce the judge that received the required number of votes to be elected as Chief Judge per said Rules of Practice, as indicated by his attestation below:

*I, Jeff Twardowski, Trial Court Administrator of the Twenty-Fourth Judicial Circuit of Illinois, hereby attest that the procedures set forth in Rule 2-1(b) of the Rules of Practice for the Circuit Court of Illinois in the Twenty-Fourth Judicial Circuit were adhered to in the balloting process, and that Daniel Emge received the required number of votes to be elected as Chief Judge.*
