**ORDER APPOINTING TEMPORARY GUARDIAN
FOR THE PERSON AND ESTATE**

THIS CAUSE comes before the Court on the Petition for Appointment of Temporary Guardian, pursuant to 755 ILCS 5/11a-4 of the Illinois Compiled Statutes, of the Person and Estate of the above-named Respondent, a person alleged to have a disability, and the Court, after hearing the evidence and argument of counsel, finds:

1. The Petitioner, resides at _____, _____, _____, _____ County, Illinois, and has been a resident of the State of Illinois for a period in excess of six months, and is qualified and willing to act as the Temporary Guardian of the Person and Estate of Respondent.

2. The Respondent, age _____, was born on _____, and resides at _____, _____, _____ County, Illinois.

3. Respondent is in need of a temporary Guardian of his/her Person and Estate for his/ her immediate welfare and protection for the reasons that he/she suffers from debilitating mental conditions, as more fully set forth in the Physician's Report filed herein and is mentally incapable of managing his/her person and estate.

4. To the knowledge of the Petitioner, no person has been appointed as Guardian of Respondent or named as her agent under a Power of Attorney.

7. That Petitioner shall be appointed the Temporary Guardian of the Person and Estate of Respondent in conformity with the Probate Act for the period of sixty (60) days from the date of this Order;
8. That it is necessary for the protection of the Respondent that the Temporary Guardian have the authority to place the Respondent in a residential care facility.

IT IS HEREBY ORDERED:

1. Petitioner is hereby appointed the Temporary Guardian of the Person and Estate of Respondent, a person alleged to have a disability, for the period of sixty (60) days from the date of this Order;
2. Petitioner shall forward copies of the Petitions filed herein along with all of the Orders entered in this cause, including a copy of the Order Appointing Temporary Guardian, and all Notices to the nearest relatives whose names and addresses are known;
3. The Temporary Guardian has the authority to place the Respondent in a residential care facility;
4. The Temporary Guardian shall file an Oath of Office;
5. The Temporary Guardian shall post a Bond as Temporary Guardian of the Estate in the amount of \$ _____, with/without security; and
6. Upon receipt of the Oath of Office and Bond of the Temporary Guardian, the Clerk of the Court shall issue Letters of Office to Petitioner as Temporary Guardian of the Person and Estate of Respondent.
