**ORDER FOR WAIVER OF CRIMINAL COURT ASSESSMENTS
& REQUEST FOR PUBLIC DEFENDER**

The Court having reviewed the *Application for Waiver of Criminal Court Assessments* hereby finds:

1. The applicant **qualified** for a **full** waiver of all assessments because (*check only one*):
 - a. The applicant receives means-based government assistance under one or more of the following programs:
 - Supplemental Security Income (SSI) (Not Social Security)
 - Aid to the Aged, Blind and Disable (AABD)
 - Temporary Assistance for Needy Families (TANF)
 - SNAP (Food Stamps)
 - General Assistance (GA), Transitional Assistance, or State Children and Family Assistance.

 - c. Payment of assessments would result in undue hardship to the applicant or his or her family.
2. The applicant **qualifies** for **partial** (*75%, 50%, or 25%*) waiver of Criminal Court Assessments because the applicant's household income is (*check only one*):
