**PETITION FOR THE APPOINTMENT OF
 TEMPORARY GUARDIAN**

COMES NOW Petitioner, pursuant to 755 ILCS 5/11a-4 of the Illinois Compiled Statutes, and petitions this Court for the appointment of Temporary Guardian of the Person and Estate the above-named Respondent, a person alleged to have a disability, and as states as follows:

1. That Petitioner resides at _____, _____, _____ County, Illinois, and has been a resident of the State of Illinois for a period in excess of six months, and is qualified and willing to act as the Temporary Guardian of the Person and Estate of Respondent;
2. That Respondent, age _____ years, was born _____, and resides at _____, _____, _____ County, Illinois;
3. That the proposed Temporary Guardian of the Person and Estate of the Respondent is Petitioner, who is over the age of 18 years, is of sound mind and under no legal disabilities, has never been convicted of a felony and meet all other requirements of §11a-5 of the Probate Act and are otherwise willing to act as Temporary Guardian of the Person and Estate of Respondent;
4. That Respondent is in need of a Temporary Guardian of his/her Person and Estate for the immediate welfare and protection of the Respondent for the reasons that he/she suffers from developmental disabilities and/or mental illness, as more fully set forth in the Physician's Report filed herein and lacks sufficient understanding or capacity to make or communicate responsible decisions concerning the care of the Respondent's person, estate and financial affairs
5. That no person has been appointed as Guardian of Respondent or named as his/her agent under a Power of Attorney.

WHEREFORE, Petitioner prays this Court enter an Order:

- A. Appointing Petitioner as the Temporary Guardian of Respondent, a person alleged to have a disability, for a period of sixty (60) days unless extended pursuant to Illinois statute;
- B. As Temporary Guardian, Petitioner shall be authorized to admit and maintain the Respondent to a residential, long-term care facility if recommended by Respondent's treating physician; and

C. Any further relief this Court deems necessary.
